All women, everywhere, recognize violence. Not only are women disproportionately affected by war, but they are routinely harmed physically and emotionally by assault and discrimination in what should be the safest spaces: their schools, workplaces, homes. As the writer Rebecca Solnit has said, "Violence doesn't have a race, a class, a religion, or a nationality, but it does have a gender." It is our common bond.

But it doesn't have to be this way. The International Coalition of Sites of Conscience is a network of over 250 museums, historic sites and memorials in 65 countries dedicated to using the past to advocate for human rights today. At this critical time – when the silence surrounding violence against women is finally being shattered – we are working with women in every region of the world on the issues that affect them most: amplifying their voices, scaffolding their projects and bringing them together across boundaries to ensure that this moment in history is not just a blip, but a global, grassroots movement for lasting change.

WHAT WE DO

As our Founder Ruth Abram says, "The history of women organizing is a bottom-up history. If it doesn't start on the ground, it doesn't work." To ensure success, the International Coalition of Sites of Conscience partners directly with women in communities across the globe who are affected by human rights abuses, providing them funding, training, networking opportunities and psychosocial support.



Our twenty-year history has taught us that lasting change comes only when victims' stories are heard. Sites of Conscience provide safe spaces for this testimony, opportunities to reflect on what led to these experiences, and avenues for action to ensure those events never recur. Here is a selection of programs supported in the past year:

We awarded a grant to Museo Sitio de Memoria ESMA in Argentina to support an initiative on the history of violence against detained women during the country's dictatorship. By shining a light on systemic violence, we are creating a movement to never let it happen again.

We led an art-based workshop for 20 female survivors of the civil war in Sri Lanka - providing them a platform to share their experiences, acknowledge those of others and break the cycle of violence. "The workshop brought me calm," one participant explained. "If whole communities did this, reconciliation would follow."

To shatter the silence around sexual violence under the Khmer Rouge, we awarded a Cambodian member a grant to collect and share oral histories of victims of that era's forced marriages. The histories led to the development of a play performed at a former site of detention, now a memorial.

The 2017 women's marches brought 4,500,000 people onto the streets. To harness this energy, we provided members with multiple avenues for action - from a rapid response guide to spark dialogue on women's rights to a Pop-Up on #MeToo and Museums held at the 2018 AASLH annual conference, reaching 20,000 history professionals and organizations.

OUR GROWTH AT A GLANCE

PERFECTLY POSITIONED

Women are uniquely positioned to be effective community leaders. An International Peace Institute study found that when women participate in peace processes, there is a 35 percent greater chance a peace agreement will last 15 years or more.

Founded in 1999, the International Coalition of Sites of Conscience is the only global learning and advocacy organization working on the ground in over 65 countries to support women in such leadership roles by:

Leading international learning exchanges to foster a global movement built on the stories of Women of Conscience to prevent recurrence of violence and promote respect for human rights;

Offering technical support and training to amplify the voices of Women of Conscience across borders and contexts though traditional and digital platforms;

Facilitating mentoring programs to give women the skills to advocate to governments and engage communities in post-conflict rebuilding;

Providing holistic support through regranting to help Women of Conscience develop effective local public programs.

With the rise of extremist rhetoric around the globe, women are leading the movements for change. Nearly 70% of women worldwide say young girls need to be encouraged to speak up more. We have never been more ready to support them.
